### **EXECUTIVE DIRECTOR'S REPORT 9:40 a.m.**

Director Caudill reviewed the Executive Director's report with the Board.

Director Caudill discussed correspondence that she sent to the Ohio High School Athletic Association requesting that their Concussion Management policy be revised to include chiropractic physicians as "appropriate health care professionals" that may clear athletes to return to play. A letter was sent to OHSAA on September 29 and November 2, 2010 with no response received to date. The OSCA was copied on both letters and has indicated they will follow up on this.

Director Caudill discussed correspondence that she sent to Robert Owen, Chief of ODH Radiation Protection requesting that the rule pertaining to diagnostic imaging services be amended to include chiropractic physicians as a provider that may order PET and nuclear medicine services. The OSCA also contacted ODH regarding this issue. To date, ODH has responded to the OSCA indicating that chiropractic physicians are permitted to order PET scans, however Director Caudill has not received a response.

Director Caudill discussed the FCLB Model Practice Act and requested that Board members submit their individual comments to her by December 17, 2010 and she will submit one response on behalf of the entire Board.
